## PRIVACY DISCLAIMER

### PURSUANT TO ART. 13 OF THE EUROPEAN REGULATION N. 679/2016 (GDPR)

In compliance with the obligations established by European Regulation no. 2016/679 (GDPR) we hereby inform you that:

1. **The Data Controller** is the company L.C. CONGRESSI S.R.L. , with registered office in Via Euganea 45, 35141 Padova (PD) Italy, VAT number and Tax ID Code 00257740282, REA number 250864, P.e.c.: lccongressi@pec.it .
2. **Object and Purpose of the processing:** the object of the processing is your common data (identification data referred to in the sponsorship confirmation form) and fiscal data necessary for the performance of the contractual relationship which will be processed for the following purposes:
  - a. For the establishment and the performance of the relationship with L.C. Congressi srl, subsequent modifications or variations and for any obligation provided for the performance of the same.
  - b. To manage the sponsorship relationship, payment and related invoicing.

4. **Refusal to provide data and mandatory communications.** The provision of your personal data is optional but necessary for the purposes of the conduct of the relationship and its proper execution.

5. **Data communication and access.** Your personal data may be disclosed to the Data Controller and to persons authorized to process and appointed by the Data Controller. The data are not subject to dissemination.

7. **Data transfer and recipients in non-EU Countries.** The Data Controller uses Google's G-Suite, which stores data in the cloud and may, therefore, store data in servers located in U.S. Google. However, Suite, as a Google Cloud solution, is compliant with applicable privacy and security regulations throughout the lifecycle of information processing.

8. **Rights of the data subject.** The GDPR gives data subjects specific rights that you may exercise against the Data Controller:
  - request access to your personal data and information relating thereto; rectification of inaccurate data or supplementation of incomplete data; deletion of personal data concerning you (upon the occurrence of one of the conditions set forth in Article 17(1) of the GDPR and subject to the exceptions set forth in paragraph 3 of the same Article); restriction of the processing of your personal data (upon the occurrence of one of the cases set forth in Article 18(1) of the GDPR); and request an updated list of Data Processors and System Administrators;
